## Pathway A: Recognition

Candidate with relevant experience may be eligible for the recognition pathway and RBHPA designation. According to the membership conditions stipulated in "Overview of BHPA" (Section 6.2) minimum educational requirements for these candidates to join the Association are a Bachelor degree level of education in the following cognate areas:

- 1. Economics,
- 2. Law,
- 3. Architecture; and
- 4. Engineering.

Furthermore, Section 6.3. of the same document (Overview of BHPA) stipulates that (to renew membership) members are requiered to attend at least two training sessions annualy. The Association provides four training sessions annualy.

## Pathway B: Education

Candidates without necessary experience are not eligible for the recognition pathway and are requiered to complete post – graduate valuation education program (based on RICS and TEGoVA standards and education requirement). Under – graduate educational requirements are the same as for the recognition pathway.

The programs that satisfy membership requirements are:

- "Master of Property" postgraduate diploma offered by Faculty of Economics in Sarajevo (Please see Attachment A), or
- Eqvivalent relevant education.

- Principles of Economics, Business and Finance, including Real Estate Economics,
- Basic understanding of Land use, Buildings and Construction,
- Basic understanding of Environmental issues,
- Business Law, including Property Law,
- Valuation principles, standards and norms, and
- Valuation methods.
